La performance de ces fonds, comme celle du fonds CPIC Part A, est **nette de tous frais**.

La performance de la part A se situe dans le premier quartile sur 5 ans (objectif de long terme).

Sur 5 ans, le **Ratio de Sharpe** (rapport de la performance en excès du taux sans risque par unité de volatilité) si situe lui aussi dans le premier quartile.
